## Program:

Thursday Evenings after Golf Course outings finish (9 weeks)

**Shotgun Starts: May 15, 29, Jun 12, 26, Jul. 31, Aug. 7, 21, Sept. 11, 18**

- Registration begins at 6:00pm each week.
- No registration after 6:30pm - Time is needed to assign hole locations on the golf course.
- Families will be permitted out to play once our staff has announced the course is clear.
- Starting holes & times may vary, will be assigned weekly. Walking Only.

## Application:

- One-time fee for the season: **\$120 per child**
- **Stamford Residents ONLY. Must have a valid driver's license or current Stamford resident permit.**
- **One** supervising adult per child can play for free
- Please make **checks payable to: "HOLE IN ONE ENT."**
- **NO REFUNDS** given due to the demand for this program.
- **All schedules subject to change at any time.**

In-person registration begins on **Saturday at 8:00am on April 12, 2025.**

Starting Monday, April 21<sup>st</sup>, any available remaining spots will be open to non-residents.

- Junior participants must be **ages 5 – 14 years.**
- Juniors and Parent/Guardian must have their own clubs.
